VETERINARY ASPECTS "A" Ponies categorized under heights below 140 cm participating in the show competition can participate under the individual NF's rules for vaccination as long as they are presenting an official vaccination card, showing the day of vaccination and the name of the treating vet. Horses vaccinated according to FEI rules can be stabled together with horses participating in the FEI event.

All ponies/horses must be presented for a pony/horse inspection on arrival

Week 1 : 30.04.2024 17:00 – 21:00, 01.05.2024 11:00 – 15:00

All ponies must log the temperature twice a day, 3 days before arrival to the showground. The log must be presented at the horse inspection on arrival.
